



## Data protection notices in accordance with Art. 13 EU-GDPR

### USPE Invitation to Enter

In accordance with articles 13 and 14 of the EU General Data Protection Regulations (EU GDPR), a responsible person in charge of a concerned, whose data they are processing, must provide the information mentioned in the articles. This leaflet complies with this information obligation.

#### **1. Names and contact details of a person in charge or their deputy:**

#### **2. Contact details of the data protection officer (male or female):**

With regards to the processing activities of the controller listed below, there is no obligation to appoint a data protection officer in the absence of the requirements specified in Art. 37 EU GDPR and § 38 BDSG.

With regards to questions related to data protection law or exercising the rights listed under section 7 of this Declaration, the general contact details of the USPE (see section 1 of this Declaration) must be used.

#### **3. Purposes of personal data processing:**

The association, called Union Sportive des Polices d'Europe (USPE) in accordance with Art. 1, paragraph 1 of the USPE Statutes of October 8<sup>th</sup>, 2016, is responsible for the task of promotion of sports within all European police forces and coordination of preparation, carrying out and control of international competitions in the types of USPE sports. This includes the following tasks:

- Planning, placing, coordination and carrying out of international competitions of police forces (European Police Championships, USPE Cups)
- Cooperation with the national and international sports organisations, especially with the host countries as well as with the participating countries



- Recognition of the European police records
- Keeping of the record lists
- Implementation of a formal registration and registration procedure in preparation of a European Police Championship / USPE Cup

In connection with the performance of the above tasks, USPE processes personal data of male and female participants of international competitions (including their last and first name, date of birth, rank, gender, nationality, police ID number and date of issue, travel dates as well as, based on the kind of sports, also weight category, sports discipline, license number, results of a competition or similar information) in cooperation with a stipulated organising member association of a Championship/Cup in accordance with article R15, par. 4 of the USPE Rules and Regulations of November 3<sup>rd</sup>, 2018 or point 1.2.1 of the Regulations governing the USPE CUP of January 1<sup>st</sup>, 2017.

This is done, in particular, in the course of creating participant, competition and result lists, which are recorded both in the files maintained by USPE, or after a competition on the internet or in the USPE publications or published in the publications of the host and participating countries as well as in the regional and possibly national press.

Furthermore, photographs and film recordings are made during and after a competition and used for the purposes of USPE, host and participating countries public relations activities.

#### **4. Legal basis of data processing:**

The processing of personal data, in particular with regard to their type and scope, is based on the principle of data minimisation anchored in Art. 5, par. 1, letter c) of EU-GDPR.

The personal data to be processed are limited to the extent necessary for the tasks / purposes listed under point 3 of this Declaration.

The necessary consent of female and male participants for the processing of their personal data must be obtained acc. to art. 6, par. 1 letter a) in conjunction with art. 7 of EU GDPR before data processing is started.

Responsibility in this case is carried by the responsible organisations of the reporting participating countries, based on the respective affiliation.



Forming the basis Declaration of consent is related hereby both to the processing of personal data in connection with the planning, placing, monitoring and hosting of the competitions in question, as well as to the publication of personal data and pictures of the participants in the context of reporting on sporting events and events of the USPE

## **5. The recipients or categories of recipients of the personal data:**

- a) responsible organisations of the host country of the European Police Championship / USPE Cup, which are responsible for planning, monitoring and organisation of those
- b) persons responsible for the organisation of the above-mentioned tasks of the Union Sportive des Polices d'Europe (USPE) including the Technical Delegates
- c) if necessary, transfer of personal data (surname, first name, date of birth) to the external bodies within the framework of organisation of accommodation and catering of the participants (hotel booking, catering, etc.)

## **6. The duration for which the personal data is stored or, if this is not possible, the criteria for determining the duration:**

The personal data obtained in the course of the registration of participants will be processed for the purposes of placing, planning and organising of a Championship/Cup and will be deleted/disposed of when the underlying purpose ceases to exist - after the Championship/Cup is finished.

The personal data, which is processed in connection with generation of result lists, will be generally published in the context of internal and / or external public relations activities after the sporting event. The result lists as such are stored unlimited at the USPE. The storage is based on a legitimate interest of the USPE in the historical documentation of sporting events and achieved results.

## **7. A person concerned disposes of the rights specified in the articles as follows:**

Right of access by the data subject acc. to Article 15 EU GDPR  
The data subject shall have the right to obtain from the controller confirmation as to whether or not personal data concerning them has been processed, and, where that is the case, access to the personal data and the information listed in Article 15, paragraph 1, letters a) to h).

**Right to correction acc. to Article 16 EU-DS-GVO**

Any person concerned has the right to request that a responsible person immediately corrects any incorrect personal data concerning them. Considering the purposes of data processing, a person concerned has the right to request completion of incomplete personal data - also by means of a supplementary declaration.

**Right to erasure/dispose of acc. to Article 17 EU GDPR**

Any person concerned has the right to request that their personal data will be immediately erased/disposed of by a controller. A person responsible is obliged to erase/dispose of personal data immediately, if one of the reasons specified in Art. 17, paragraph 1 a) to f) is applied.

**Right to limit personal data processing acc. to Article 18 EU GDPR**

Any person concerned has the right to request a responsible person to limit their personal data if one of the conditions listed in Art. 18, paragraph 1, letters a) to d) has been met.

**Right to data transferability acc. to Article 20 EU GDPR**

Any person concerned, among others, has the right to receive their personal data which they have provided to a responsible person, in a structured, common and typed format, provided that data processing is based on a consent in accordance with Art. 6, paragraph 1, letter a).

**Right to withdraw consent provided acc. to Article 7, paragraph 3 of EU GDPR**

Any person concerned has at any time the right to withdraw their consent to personal data processing. The withdrawal of the consent does not affect the legitimacy of data processing which has taken place before the withdrawal.

**Right to file a complaint with a supervisory authority under Article 77 EU GDPR**

Any person concerned shall without prejudice to any other administrative or judicial remedy have the right to complain to a supervisory authority, in particular in their member country or their habitual place of residence, their place of work or location of the alleged violation, if a person concerned is of the opinion that their personal data processing violates this regulation.

There is no data collection from third parties.
