Participation in championships is restricted to athletes, who:

1. meet the starting requirements of their international union,
2. belong to a national sports organisation that is a member of the USPE,
3. actually, is a member of police organisation/force at the time of the championship or
4. are police students at a public police academy,
5. have reached the age of 18 at the time of the championships (including preliminary rounds),
6. have signed the Anti-Doping Declaration,

**The personal details and data of all participants, listed on pages 3 and 4 in the original form, have been obtained and provided to USPE by the participating member country. Art. 6 par. 1 lit, and art. 7 of European General Data protection Regulation 'GDPR' refers. This allows for the use of personal data before, during and after the competition, as well as subsequent documents, photographs and videos that may be produced, for example by USPE.**

**It is the responsibility of the participating member country to ensure that every participant from their member country has consented to the GDPR agreement and the original consent document should be held by the member country.**

- **Date of Birth:** Day / Month / Year
- **Police ID - Date of issue/expiry:** Day / Month / Year
- **Anti-Doping Declaration:** The Declaration must be signed by the participants.

- All delegates, attendants and athletes are responsible for bringing the Anti-Doping Declaration themselves; and their Passport or a National ID (with a photo).
- The member countries are responsible for the data protection of the data of their participants. Sending this form by unencrypted e-mail is not a secure way of transmission. It is recommended to send the form by post, fax or encrypted e-mail.
